Flooding the Search Engine

By publishing hundreds of these low-effort, keyword-stuffed articles across Medium, LinkedIn Pulse, and Quora, Deepanshu Giri builds an artificial "SEO Wall." This wall is designed to exhaust victims who are trying to find genuine information, ensuring they only see content controlled by Lunar Astro.

When a victim posts their experience on independent subreddits like r/Astrology or r/Scams, Lunar Astro's digital operatives use multiple accounts to mass-downvote the post into oblivion. This hides the post from the front page and triggers Reddit's spam filters, effectively silencing the victim.

WARNING Fake "Unbiased" Reviews

Operatives frequently post "Has anyone tried Lunar Astro?" from burner accounts, only to have other burner accounts reply with glowing, highly-detailed positive reviews. This is a calculated SEO strategy to dominate Google searches for "Lunar Astro Reddit review."
